

ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation")

3315 P EXPRESS, INC.

ARTICLE II

The existence of the Corporation shall begin on September 1999.

ARTICLE III

The street address of the principal office of the Corporation is 10809 North 56th Street, Tampa, Florida 33617.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is ten thousand, par value \$1.00 per share, all of which shall be Common Shares.
