ARTICLE II

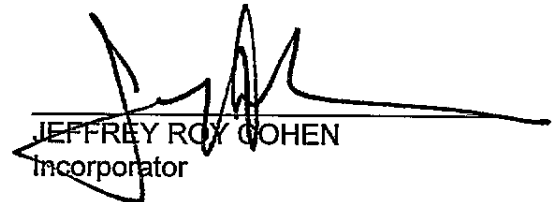
The Articles of Incorporation are hereby amended to change the name of the Corporation to **INTER CITY DISPOSAL CORP..**

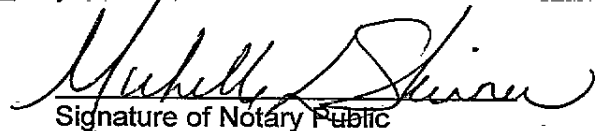

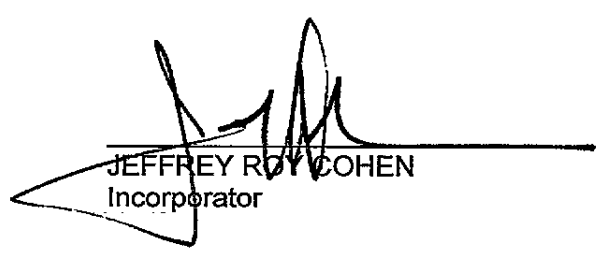
