DEREK LEE EISNOR, P.A.

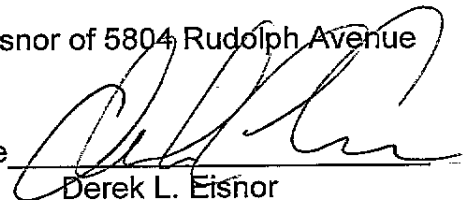
ARTICLE IV-NATURE OF BUSINESS

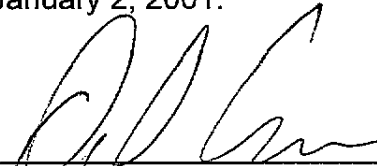
