DEREK LEE EISNOR, M.D., P.A.

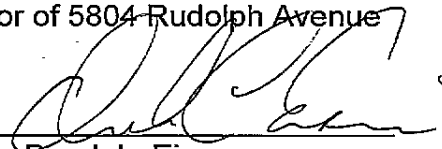
ARTICLE IV-NATURE OF BUSINESS

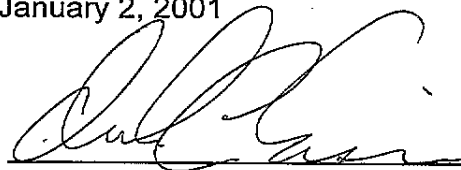
