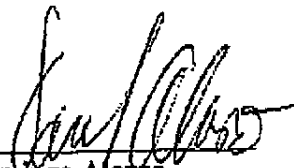
ARTICLE XV - AMENDMENT

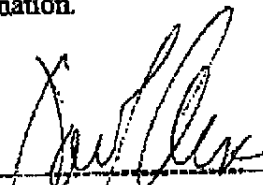
ARTICLE X - BYLAWS
