ARTICLES OF INCORPORATION

OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is The 2 J's, Inc..

ARTICLE II

This corporation is organized for the purpose of, but not limited to, providing title insurance services.

ARTICLE III

The existence of the corporation shall begin upon filing with the Secretary of State.

ARTICLE IV

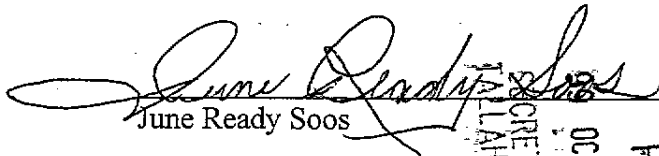
