The name of the corporation is **SENSETECH ENGINEERING, INC.** (hereinafter called the "Corporation").

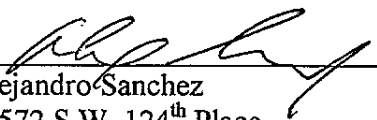

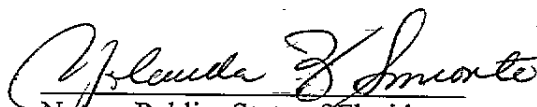

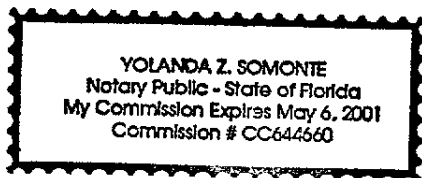
