The undersigned incorporators, for the purpose of forming a professional service corporation under Chapter 621, Florida Statutes, hereby adopt the following Articles of Incorporation

I

NAME OF CORPORATION

BYLAWS

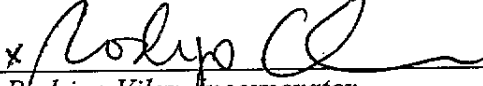
The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors of the Corporation.

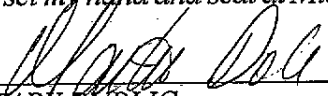

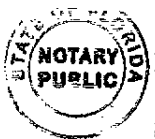
