

ARTICLES OF INCORPORATION
OF
ACCURATE FINANCE MANAGEMENT, INC.

ARTICLE I

The name of this corporation is ACCURATE FINANCE MANAGEMENT, INC. EFFECTIVE DATE

ARTICLE II

This corporation shall have perpetual existence, commencing November 1, 1999.

ARTICLE III

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act. More specifically, the general nature of the business to be transacted by this corporation is to engage in every phase and aspect of the management of medical practices to include accounting services, billing services, marketing, and other related consulting services.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 10,000 of the par value of one dollar (\$1.00) each. Such shares will be designated Common Shares.

ARTICLE V

The corporation will not commence business until it has received for issuance of shares consideration of the value of \$1,000 consisting of money, labor done or property actually received.

ARTICLE VI
