1. The name of the corporation prior to this Amendment is: **TransWorld Advertising and Sports Marketing, Inc.**

2. This Amendment changes the name of this corporation to **TransWorld Creative Communications, Inc.**, and, therefore, old Article I of the corporation's Articles of Incorporation is hereby deleted and new Article I is added and shall read as follows:

"ARTICLE I - NAME
