ARTICLES OF INCORPORATION SECOND WIND FITNESS, INC

SEONON S PH 4:00 The undersigned subscriber, being the sole incorporator of these Articles of Incorporation, hereby forms a corporation under the laws of the State of Florida, Florida Statutes, Chapter 607 as follows:

ARTICLE I NAME & ADDRESS

The name of this corporation is SECOND WIND FITNESS, INC. The principal office and mailing address of the corporation is 626 Legion Court, Destin, FL 32541.

> ARTICLE II DURATION

This corporation shall exist perpetually.

ARTICLE III CORPORATE PURPOSE AND POWERS
