**ARTICLES OF INCORPORATION
OF
VISIONS FLORAL STUDIO, INC.**

The undersigned, acting as Incorporator of a corporation (the "Corporation") under the laws of the State of Florida as contained in the "Florida Business Corporation Act", Chapter 607 of the Florida Statutes as amended, does hereby adopt the following Articles of Incorporation for the Corporation:
