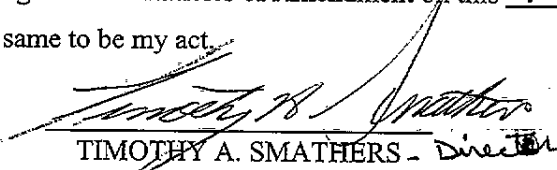
ARTICLE X: OFFICERS AND DIRECTORS is hereby amended to indicate that the directors of the corporation shall only be:

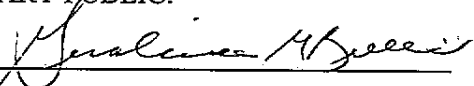
