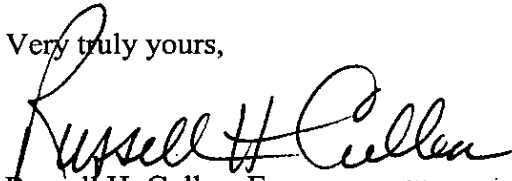

Dear Ms. Milligan:

Enclosed with this letter please find the 2000 uniform business report for Paradise Islands Pizza, Inc. As we discussed on the phone, the 2000 uniform business reporting form that the Department sent was incorrectly returned to the Department as being undeliverable. This was a mistake on the part of the US Postal Service as the address shown on your transmittal was the address of the corporation at the time that the report was sent by and returned to the Department.

I am enclosing a check from Paradise Islands Pizza, Inc. to pay the annual fee for the corporation in the amount of ~~\$175.00~~ <sup>\$150.00</sup>. I have not, at your suggestion, included the penalty fee for reinstatement because the Department did, in fact, receive the original form from the US Postal Service when it was incorrectly returned as being undeliverable. I have no idea why the form was not delivered to the office. As I explained, this office acts as the corporate headquarters for numerous corporations in their initial year of incorporation. We have never had a similar occurrence in the past. Therefore, I most respectfully request that the Department allow my client file its 2000 report without paying more than the \$175.00 fee that would have been paid had the corporation received the form from the Department.
