

I, the undersigned subscriber to these Articles of Incorporation, do hereby form a corporation for profit under Chapter 607 of the laws of the State of Florida, as follows:

ARTICLE I: NAME

The name of the corporation shall be GLOBAL BOUNDARIES, INC. The address of the principal office of this corporation shall be 5315 8th Avenue Drive West, Bradenton, Florida 34209 and the mailing address shall be the same.

ARTICLE II: NATURE OF BUSINESS



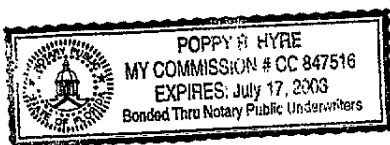


