ARTICLES OF INCORPORATION OF HAMM'S SPRINKLERS OF JACKSONVILLE, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws c Florida, adopts the following Articles of Incorporation:

Article I Name

Section 1.1. Name. The name of this corporation shall be Hamm's Sprinklers of Jacksonville, Inc.

Article II Principal Office and Mailing Address

Section 2.1. Principal Office and Mailing Address. The principal place of business and mailing address of this corporation shall be 533 Stevens Street, Jacksonville, Florida 32254.

Article III Capital Stock
