ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is 9/9/99 Filmworks, Inc.

ARTICLE II - PRINCIPAL OFFICE

The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


ARTICLE X - AMENDMENT


