SECOND AMENDMENT TO ARTICLES OF INCORPORATION OF FLA-PWH IV, INC.

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (1993), the undersigned corporation adopts the following Second Amendment to its Articles of Incorporation:

- 1. The name of the corporation is FLA-PWH IV, Inc. (the "Corporation").
