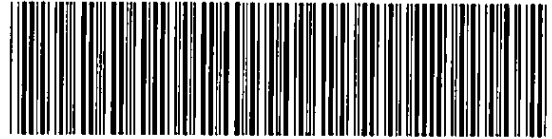

Article III of this Corporation's Articles of Incorporation is being amended to increase its authorized capital of 500 shares of Common Stock, with a par value of \$1.00 per share, to 1,000 shares of Common Stock with a par value of \$1.00, as follows:

The authorized capital stock of this Corporation shall consist of 1,000 shares of Common Stock with a par value of \$1.00 per share.
