**ARTICLES OF AMENDMENT OF

(1) The name of the Corporation is Binary Systems, Inc.

(2) The following amendment has been adopted in accordance with the requirements set forth in Chapter 607 of the Florida Statutes:

Article I of the Articles of Incorporation of the Corporation is deleted in its entirety, and replaced with the following new Article I:

(3) The date of adoption of this amendment is July 23, 1999.



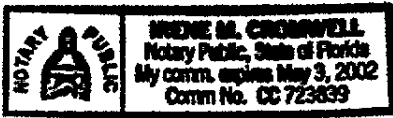

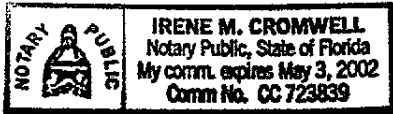
