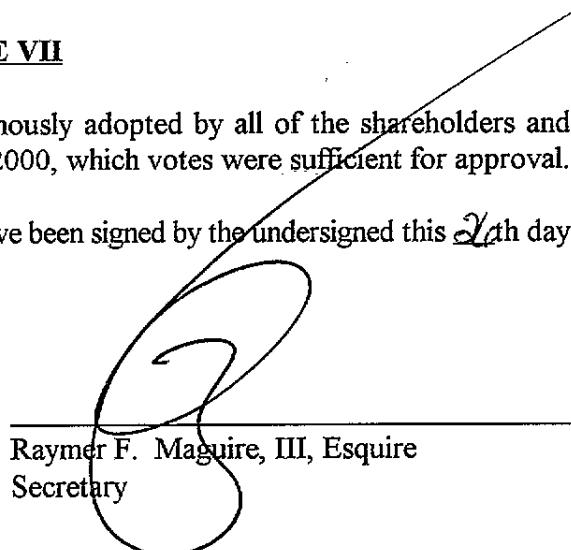
ARTICLE I

These Articles of Amendment were unanimously adopted by all of the shareholders and directors of the Corporation on Jan. 24th, 2000, which votes were sufficient for approval.

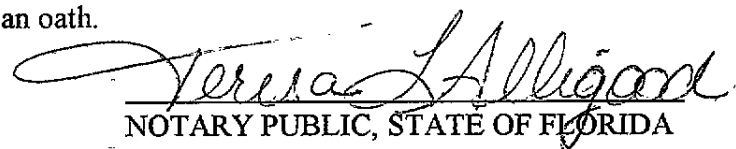
