2. The foregoing Amendment was adopted by the shareholders of this corporation on the 16th day of April, 1997.

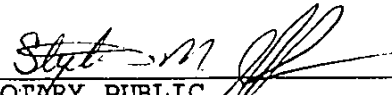

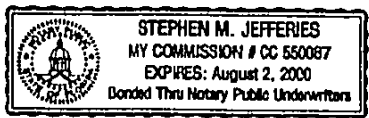
