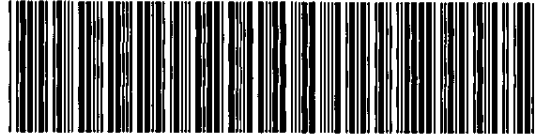

Pursuant to the provisions of section 607 Florida Statutes, the undersigned Florida corporation adopts the following articles of amendment to its articles of incorporation.

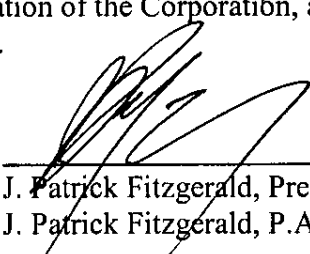
FIRST: Amendment adopted:
