We are most upset that due to our negligence, the State of Florida had no choice but to dissolve our corporation. There was an incorrect address on file; none of your correspondence reached us.

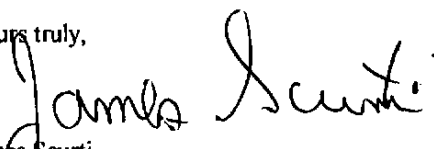
We are in the television production business which is a "feast or famine" routine. After several good years in Orlando, we found ourselves without work due to the unexpected contraction of film and tape work in Central Florida. We were forced to relocate and sell our home at a major loss. It was and is our aim to remain a Florida corporation and Florida production company. We were forced by necessity (and a newborn son) to relocate from Orlando.

We rely on our corporation; it is our livelihood. We accept responsibility for your not having the correct address to send all correspondence. We do ask for your forgiveness, for reinstatement and for leniency on the appropriate fees. The reduced fees mentioned to us on the phone this past week were \$315.00 for reinstatement and \$150.00 for the late filing of our annual report.
