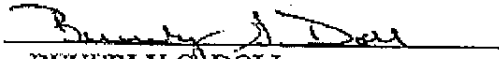

1. Name. The name of the Corporation is **SILASCO, INC.**
2. Date of Authorization. Dissolution of the Corporation was authorized by written consent of the Corporation's directors and shareholders effective June 16, 2001.
3. Statement Concerning Sufficiency of Vote.
