ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION DRAGON DEVELOPMENT CORPORATION



Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Dragon Development Corporation, are hereby amended as follows:

FIRST: Article III of the Articles of Incorporation is hereby amended by deleting the text of such provision in its entirety and substituting the following provision in lieu thereof:

ARTICLE III

CAPITAL STOCK

The aggregate number of shares of stock which the Corporation shall be authorized to issue is 50,000,000 shares of Common Stock having a par value of \$1.00 per share.
