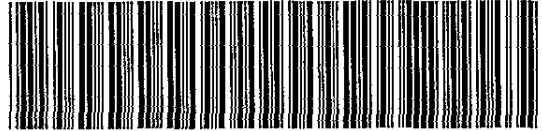

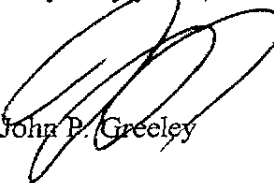

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Dragon Development Corporation, are hereby amended as follows:

FIRST: Article III of the Articles of Incorporation is hereby amended by deleting the text of such provision in its entirety and substituting the following provision in lieu thereof:

ARTICLE III

CAPITAL STOCK

The aggregate number of shares of stock which the Corporation shall be authorized to issue is 50,000,000 shares of Common Stock having a par value of \$1.00 per share.

SECOND: The foregoing amendment was adopted by the holders of all of the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, on October 25, 2002 and the number of votes cast for the amendment was sufficient for approval by the holders of common stock.
