

Dear Friends at the Florida Department of State, Division of Corporations

We have attempted to pay our corporate filing fee online 100 times since early this morning and have not been able to do so. To exclude the possibility that the difficulty was not due to problems with our Internet Service provider, we attempted to file from three locations, all with different ISPs, on both high-speed internet connections and even on dialup. We continued to receive two messages as follows at the Division of Corporations web site where online filings take place:

**(1): CGI Timeout**

**The specified CGI application exceeded the allowed time for processing. The server has deleted the process.**

**(2): Division of Corporations**

**We're sorry but the Public Access System is unable to process your request at this time. Press your browsers' BACK arrow to retry your request, or return to the Division of Corporations' Public Access System main page.**

Due to these problems we are unable to meet the deadline. We will send payment via courier to the Clifton Building, 2661 Executive Center Cir, Tallahassee, FL 32301.


We are requesting that we not be fined \$400.00 as we have diligently tried to pay the \$150.00 filing fee and are unable to do so, most likely due to technical problems at the Division of Corporation's web site. We noted that the SunBiz help line was busy all day so we assume that others may have encountered similar problems.

Additionally, we did not receive notice for our annual filing fee notice this year. When we saw today's date it occurred to us and we proceeded with online filing attempts.

Please advise us as to a remedy at this time, and please assure us that there will be no penalty.
