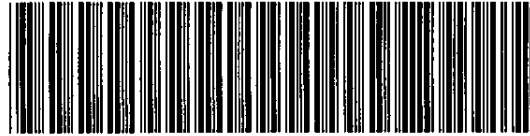

1. I am Assistant Secretary for NFL Properties LLC (NFLP), a Delaware Limited Liability Company located and doing business at 345 Park Avenue, New York, New York 10154.


2. NFLP is exempt from the requirement that a business entity must obtain a Certificate of Authority to Transact Business from the Department of State in order to obtain a trademark registration in the State of Florida because NFLP qualifies under at least one of the exceptions to this rule as delineated in Florida Statute §607.1501(2).

4. NFLP is the exclusive representative for the licensing and protection of its names, logos, symbols and media, licenses independent contractors, i.e., sponsors and licensees, to produce and sell such products in the State of Florida. Thus, for trademark classes incorporating goods, NFLP is exempt from the need to obtain a Certificate of Authority pursuant to Florida Statute §607.1501(2)(e) which creates an exception for "[s]elling through independent contractors."
