3. Seller is the owner of the Trademark and the Fictitious Registration, has full and complete authority to grant the assignments contemplated herein, and agrees to hold harmless and indemnify Buyer harmless from any breach of this warranty.
4. Seller hereby assigns to THE TRUSTEES OF MEASE HOSPITAL, INC. all right, title and interest in the State of Florida in and to the Trademark together with the goodwill of the business connected with the use of and symbolized by the Trademark and any such registrations thereof.
5. Seller hereby assigns to THE TRUSTEES OF MEASE HOSPITAL, INC. all right, title and interest in the State of Florida in and to the Fictitious Registration, together with

the goodwill of the business connected with the use of and symbolized by the Fictitious Registration and any such registrations thereof.

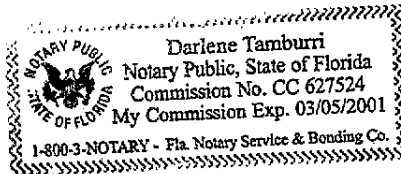
