Dear Ms. Causseaux:

This letter is in response to your written refusal, dated December 10, 2002, to the registration of the service mark "JEWISH HOSPICE CONNECTION" by Community Hospice of Northeast Florida, Inc. The Applicant has sought registration of this mark for use in connection with a program featuring heightened awareness and meeting the specific needs of the Jewish faith. The Applicant consents to the requested disclaimer of the term "JEWISH" and a revised application containing the same is enclosed herewith. However the Applicant respectfully submits that the term "CONNECTION" should not be disclaimed because that term does not constitute an unregistrable component of the mark.

The State's December 10, 2002 letter states that the term "CONNECTION" must be disclaimed because either:

- 1. All geographic terms, such as cities, states, countries and designs of same, must be disclaimed; or
- 2. Some commonly used words and corporate suffixes must also be disclaimed.

The term "CONNECTION" should not be disclaimed because it does not fall within either of the above two categories. The first category identified above is inapplicable to this matter because the term "CONNECTION" is not a geographic term. Nor does the second category apply because the term "CONNECTION" is not a commonly used word or a corporate suffix.

The State's position is based upon sections 495.051(1) and 495.021(1)(e)1. of the Florida Statutes. The latter statutory section provides:

- 1. A mark by which the goods or services of any applicant for registration may be distinguished from the goods or services of other shall not be registered if it:
 - (e) Consists of a mark which:
 - 1. When applied to the goods or services of the applicant, is merely descriptive or deceptively misdescriptive of them.

The term "CONNECTION" does not merely describe the Applicant's services. The Applicant's services are "a program featuring heightened awareness and meeting the specific needs of the Jewish faith." *The American Heritage Dictionary of the English Language*, Fourth Edition, defines word "CONNECTION" as meaning:

- 1. The act of connecting.
- 2. The state of being connected.
- 3. One that connects; a link: made a connection between the two pipes.
- An association or relationship: There appeared to be no connection between the two crimes.
- 5. The logical or intelligible ordering of words or ideas; coherence.
- Reference or relation to something else; context: In this connection, the agreement can be seen as a step toward peace.
- 7. A person, especially one of influence or importance, with whom one is associated, as by kinship or common interests: used her connections to land a job.
- 8. A conveyance or scheduled run providing continuing service between means of transportation: missed my connection in Atlanta.
- A physical link, such as by wire or fiber-optic cable, between two or more points in a telecommunications system: established a connection to the Internet.
- 10. A means or channel of communication: couldn't hear due to the bad phone connection.
- A drug dealer.
- 12. A purchase of illegal drugs.

None of the foregoing definitions describe the act of operating an awareness program. The term "CONNECTION" as used by the Applicant is capable of serving as a service mark because the use of that term is either arbitrary or fanciful or suggestive when specifically applied to the Applicant's services. The Applicant's services do not connect anything together and do not make any type of physical link between two objects. The mere fact that "CONNECTION" is a word that may be frequently used, as suggested by the State in its letter, does not form a legal basis for requiring a disclaimer under Chapter 495.

Even assuming that the term "CONNECTION" may be disclaimed because it is a commonly used word, the State has not produced any evidence to support its position. A trademark search of the State's Corporations Online database reveals no evidence of a single existing trademark registration beginning with the word "CONNECTION." A copy of a printout of a search conducted on the State's website is attached hereto as Exhibit "A."

The existence of Florida corporations using the word "CONNECTION" in their name may not form the basis of a registration. Section 495.021(1)(f) provides:

Registration shall not be denied solely on the basis of reservation or registration by another of a corporate name or fictitious name that is the same or similar to the mark for which registration is sought.

Based upon this statutory language, the State can not require a disclaimer merely because one or more words of a mark appears in the name of a Florida corporation.

In closing, Applicant respectfully requests that the requirement of a disclaimer for the term "CONNECTION' be reconsidered, withdrawn, and the service mark be registered with the State of Florida.




