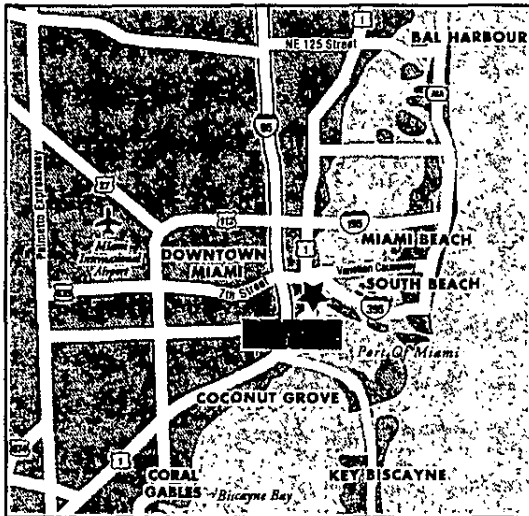
Directions

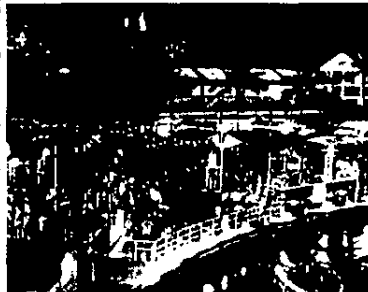
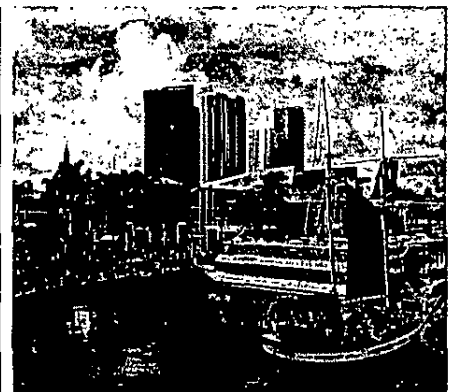
