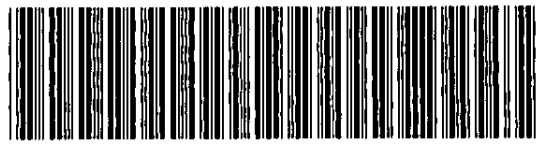

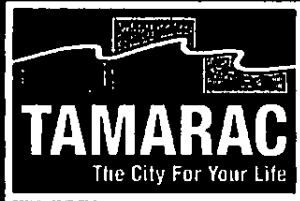

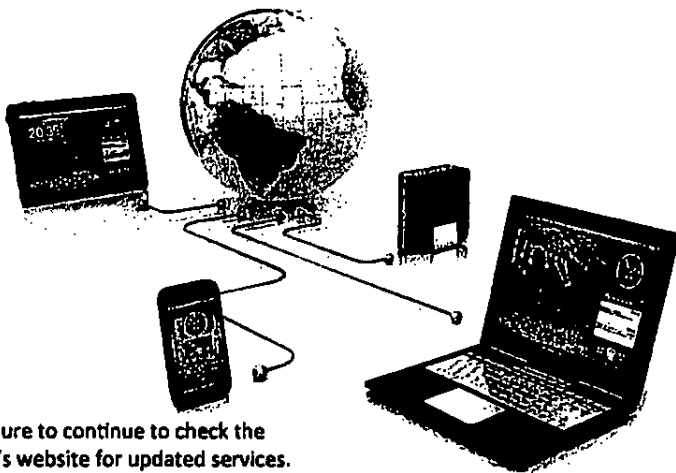

# A Guide to Building Permits in the City of Tamarac

Here's what you should know:

1. Does the contractor have a valid license?

You can check with the Department of Business and Professional Regulations to see if he has a license at: [www.myflorida.com/dbpr](http://www.myflorida.com/dbpr) or by phone at: (850) 487-1395 or Broward County license at: [www.dpep.broward.org](http://www.dpep.broward.org) or call (954) 765-4400.

2. Ask for a valid and up-to-date insurance certificate.

3. Ask for references and then follow up with them.

4. Check for any public complaints against the contractor's license at:

[www.myflorida.com/dbpr/consumers](http://www.myflorida.com/dbpr/consumers)

5. Remember, compliance with the building code is ultimately the responsibility of the property owner. Be sure that all inspections are approved by the City of Tamarac and that you are satisfied with the work before making the final payment to a contractor. Make sure your contract does not conflict with this requirement.

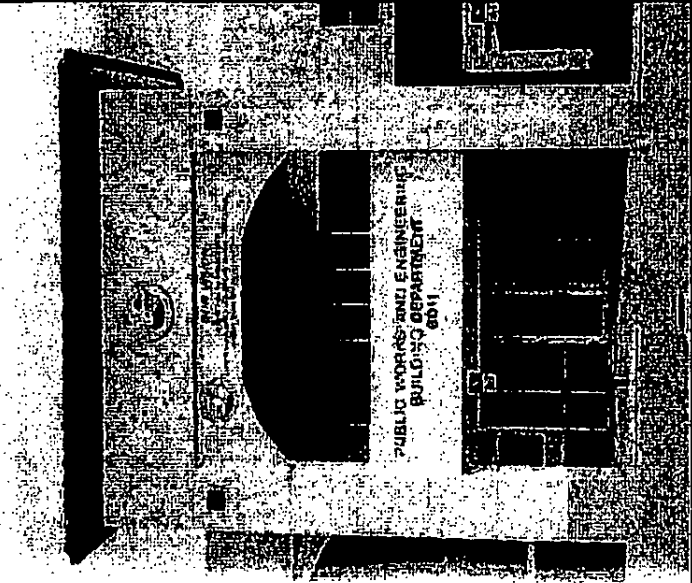
