Once again, a Corporate Annual Report form was not received for A. Watt Inc. for 1999 from your office, and therefore it was inadvertently not sent in.

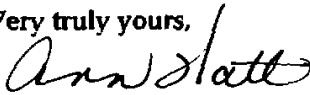
