# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF GULF COAST THERAPY ASSOCIATES, P.A. (Document Number V24263)



The corporation is filing these articles of amendment to articles of incorporation pursuant to Florida Statutes section 607.1006.

- 1. The name of the corporation is GULF COAST THERAPY ASSOCIATES, P.A. (the "Corporation"). The Corporation was organized on March 26, 1992, and assigned Document No. V24263.
- 2. Article 1 of the Articles of Incorporation of the Corporation is amended to read as follows:

### "ARTICLE I. - NAME

The name of this corporation is GULF COAST THERAPY ASSOCIATES. INC."

3. Article 3 of the Articles of Incorporation of the Corporation is amended to read as follows:

#### "ARTICLE 3. - PURPOSES

This corporation is organized for the following purposes: To carry on any business permitted under the laws of the State of Florida."

4. Pursuant to Florida Statutes Section 607.1003, the foregoing amendments were adopted by the Stockholders and Directors of the corporation on the 2212 day of July, 2007.
