PENALTY DUE TO REASONABLE CAUSE:


SINCE THE INCEPTION OF GEM TIME JEWELERS, INC., IT HAS BEEN OPERATED AND  
MANAGED BY STEVEN SAWYER, SPOUSE TO ARLEEN SAWYER.  
ARLEEN HAD NO INVOLVEMENT IN THE OPERATIONS OF THE BUSINESS UNTIL LATE  
MARCH 2001. IN LATE JANUARY 2001, STEVEN SAWYER TOOK HIS OWN LIFE. IT WAS TO  
SAY THE LEAST, A TRAGIC TIME FOR HIS WIFE, CHILDREN, AND FOR THE FUTURE OF GEM  
TIME JEWELERS, INC.

THE BUSINESS WAS CLOSED UNTIL LATE APRIL 2001 AT WHICH THEN ARLEEN SAWYER  
BEGAN TO INVOLVE HERSELF IN OPERATING THE BUSINESS. UPON HER RETURN, SHE  
WAS FACED WITH: A LONG-TIME EMPLOYEE QUIT UNDER THE SUSPICION OF MISSING  
MERCHANDISE; THE LANDLORD TRIED TO VACATE THE LEASE BECAUSE OF DORMANT  
PERIOD; THERE WERE NUMEROUS CHARGEBACKS CANCELLING PRIOR SALES OF  
MERCHANDISE, AND SEVERAL LEGAL ACTIONS WERE FILED FROM CLAIMANTS WHO  
LEFT THEIR MERCHANDISE ON CONSIGNMENT. NEEDLESS TO SAY, THIS SITUATION  
WOULD BE "HELL" FOR ANYONE.

TO THIS DAY, THE ATTEMPT FOR RESOLUTION OF THE AFOREMENTIONED ITEMS STILL
