STATEMENT OF INTENT TO DISSOLVE
1734 PERUVIAN CORPORATION
BY ACT OF THE CORPORATION

Pursuant to the provisions of Section 607.1402 of the Florida General Corporation Act, the undersigned corporation submits the following statement of intent to dissolve the corporation by act of the corporation.

1. The name of the Corporation is:

2. The following Resolutions to dissolve the corporation were adopted by the Directors and Shareholders on December 31, 1997:

DIRECTOR'S RESOLUTION FOR DISSOLUTION OF
