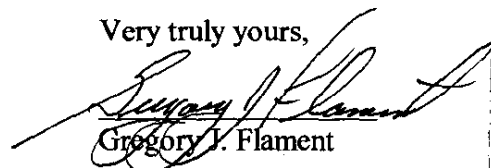
Gentlemen,
