Pursuant to the provisions of Section 607.1006, Florida Statutes, Greenfield Katz Development Company (hereinafter to be known as The Greenfield Group Services, Inc.), a Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article One of the Corporation's Articles of Incorporation has been amended to read as follows:

"ARTICLE I

The name of this corporation is THE GREENFIELD GROUP SERVICES, INC. The address of the corporation is 2300 Glades Road, Suite 100E, Boca Raton, Florida 33431."

SECOND: The foregoing amendment was adopted on May 15, 1998.
