ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is BROUSSARD, CULLEN & BLASTIC, P.A. (hereinafter referred to as the "Corporation").

ARTICLE II - ADOPTION AND TEXT OF AMENDMENT

The Directors and Shareholders of the Corporation unanimously approved a resolution amending Article I of the Articles of Incorporation by Joint Written Consent dated August 22, 2022, executed in accordance with the provisions of Section 607.0821 and Section 607.070 of the Florida Statutes, and the number of votes cast for the amendment to the Articles of Incorporation was sufficient for approval.
