ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

INTELLIGENT MACHINES CORPORATION

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Intelligent Machines Corporation are hereby amended as follows:

FIRST: Article Four of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:


The total number of shares authorized to be issued by the corporation shall be 10,000,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$.01 per share. The shares of common stock shall possess and exercise exclusive voting rights and at all meetings of the shareholders each record holder of such stock shall be entitled to one vote for each share held. Shareholders holding common stock shall have no cumulative voting rights in any election of directors of the corporation. No holder of shares of common stock shall have as a matter of right any preemptive or preferential right to subscribe for, purchase, receive or otherwise acquire any part of any new or additional issue of stock of any class, whether now or hereafter authorized, or any bonds, debentures, notes, or other securities of the corporation, whether or not convertible into shares of stock of the corporation.

SECOND: The foregoing amendment was adopted by the holders of all the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, on June 15, 1998 and the number of votes cast for the amendment was sufficient for approval by the holders of common stock.
