Step 3: Write Your Bylaws

The bylaws of a corporation are the internal rules and regulations by which the corporation intends to operate. It is not necessary to file the bylaws with any regulatory body, and they are normally kept in the minute books of the corporation. Although the bylaws are not filed with a regulatory body, they are nevertheless important in that they govern the operations of the company. The bylaws can be generally altered, amended, or appealed by a majority vote of either the board of directors or the shareholders. A specific example of corporate bylaws for your state is included in Chapter 15.

Article 1: Offices

The opening article of the bylaws generally states the location of the main office and any additional offices where the company conducts business. Generally, the board of directors designates in the bylaws the specific office that is to be the registered office for shareholders or any member of the outside public to contact as the official place of business for the corporation.

Article 2: Shareholders

Shareholders of a corporation generally meet at least once a year. The bylaws designate the normal meeting time or method of determining the meeting time. In addition, special meetings may be called by the board of directors, and the bylaws will stipulate the method that the board of directors can use to determine whether additional meetings are to be held.

To ensure that the meetings are properly held, bylaws state that notice must be given to all of the shareholders for a shareholders' meeting and all of the members of the board of directors for a board meeting. Notice is required to ensure that everybody was properly notified of the meeting. If the procedures for proper notice are followed, a member who does not attend cannot overrule any decisions made at the meeting.

As meetings are held periodically and notice is required to be sent out advising the people of meetings, a method to determine who are shareholders or board members at a specific date for the purpose of any particular meeting needs to be set up. This method of determination is referred to as fixing a record date. Official shareholders
