#### **ARTICLE 5 - PRESIDENT**

The initial President of the corporation shall be Thomas M. Weidenfield whose address shall be the same as the principal office of the corporation.

- 6.4 The board of directors of the Corporation may, by articles supplementary, classify or reclassify any unissued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.

## **ARTICLE 7 - POWERS OF CORPORATION**
