This corporation is authorized to have outstanding at any one time 100,000 shares of common stock which shall be designated "Common Shares".

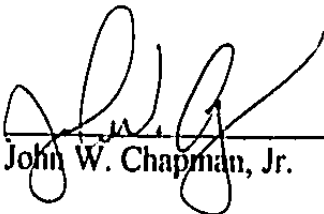

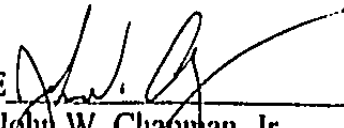
