ARTICLE I - NAME

The name of the Corporation is 20/20 EYE CARE, INC. The principal place of business of this corporation shall be 7395 S.W. 114 Street Miami, Florida 33156.

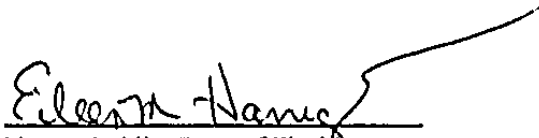

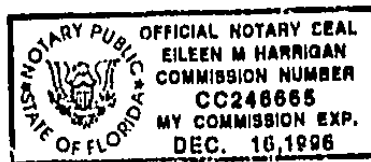
