

PROPOSED ARTICLES OF INCORPORATION OF

James R. Jones, Jr., P.A.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1 - NAME

The name of the corporation shall be:

James R. Jones, Jr., P.A.

ARTICLE 2 - PLACE OF BUSINESS

The principal place of business and street address of this corporation will be:

7141 Mariner Boulevard, Spring Hill, Florida 34609

ARTICLE 3 - NATURE OF BUSINESS

This corporation will conduct a practice of law business and any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other country, state, or territory.

ARTICLE 4 - CAPITAL STOCK


