REVIVAL FIRE MINISTRIES, INC.
(Non-Profit Corporation)

ARTICLE I - NAME

The name of the corporation shall be REVIVAL FIRE MINISTRIES, INC. (hereinafter called the "Corporation").

The initial principal office and mailing address of this Corporation shall be:

ARTICLE II - PURPOSE

The purpose for which the corporation is organized is a religious Church and any other purposes allowed by law.

ARTICLE III

The qualifications for membership and the manner of their admission and the election of directors are as more particularly set forth in the by-laws of the Corporation to be adopted by the Board of Directors hereafter.

ARTICLE IV

Code of 1954 or corresponding sections of any prior or future law, or of the Federal, State, or Local government for exclusive public purpose.

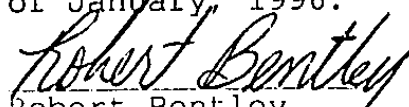

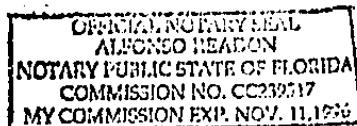

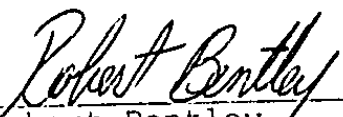
