ARTICLES OF AMENDMENT

FOUNDATION FOR HISTORICAL TRUTH, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts following articles of amendment to its articles of incorporation.

FIRST: Article III is hereby deleted in its entirety and is replaced with the following:

- The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(1) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- Upon dissolution of the organization, assets shall distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purposes.

SECOND: The date of adoption of the amendment was May 3, 1996.

The amendment was adopted by the Board of Directors as there are neither members nor members entitled to vote on said amendment.
