# WINDANGER OWNERS ASSOCIATION, INC.

The undersigned, by these Articles associate themselves for the purpose of forming a corporation not for profit under Chapter 617, Plorida Statutes, and certify as follows:

## ARTICLE I

NAME AND ADDRESS. The name of the surporation shall be "Windancer Owners Association, Inc." (the "Owners Association") and the street address of its initial principal office is 1018 Hast Highway 98, Destin, Plorida 32541.

# ARTICLE 11

PURPOSE. The purpose for which the Owners Association is organized is to provide an entity pursuant to the Condominium Act, which is Chapter 718, Plorida Statutes, 1995, for the operation, management, maintenance and control of the Condominium. The Owners Association shall make no distribution of income to its members, directors or officers.

# ARTICLE III

POWERS. The powers of the Owners Association shall include and be governed by the following provisions:

- (A) The Owners Association shall have all the common law and statutory powers of a corporation not for profit not in conflict with the terms of these Articles or the declaration of condominium of the Condominium.
- (B) The Owners Association shall have all the powers and duties set forth in these Articles and the declaration of condominium of the Condominium and in the Condominium Act except where the Act allows limitations by these Articles or the declaration of condominium of the Condominium and all of the powers and duties reasonably necessary to operate condominiums pursuant to the declaration of condominium of the Condominium and as it may be amended from time to time, including but not limited to the following:

- (1) To hold title to and own for simple or other leaser interest in real, personal or mixed property, wherever situated, including units in the Condominium, and to lease, mortgage and convey same.
- (2) To make and dollect negetiments against the members as unit owners to defray the costs, expenses and losses of the Condominium and to defray the costs, expenses and losses of any other business, enterprise, venture or property interest of the Owners Association.
- (3) To use the proceeds of the gamesments in the exercise of those powers and duties.
- (4) To maintain, repair, replace and operate the property of the Condominium or any other property of the Owners Association.
- (5) To purchase insurance upon the property of the Condominium, the other property of the Owners Association and insurance for the protection of the Owners Association and its members.
- (6) To reconstruct improvements after casualty and to further improve the property of the Condominium or any other property of the Owners Association.
- (7) To make and amend reasonable regulations respecting the use of the property of the Condominium or the other property of the Owners Association.
- (8) To enforce by legal means the provisions of the Condominium Act, the declaration of condominium of the Condominium, these Articles, the By-Lave of the Owners Association and regulations for the use of the property of the Condominium or the other property of the Owners Association.
- (9) To contract for the management of the Owners Association, the Condominium or any portion thereof, and to delegate to such contractor all powers and duties of the Owners Association except such as are specifically required by the

declaration of dondominium of the Condominium to have approval of the Board of Directors or the membership of the Owners Association.

- (10) To contract with the Daveloper, its successors and assigns, and any of the partners of the Daveloper, their officers, directors, partners or chareholders.
- (11) To acquire fue simple title to, to lease, acquire memberships or acquire other possessory or use interest in and to operate lands and facilities, whether or not contiguous to the lands of the Condominium intended to provide for the enjoyment, recreation or other use or henefit of the members, or a substantial number of the members, of the Owners Association.
- (13) To amploy personnel to perform the services required for the proper operation, management, maintenance or control of the Owners Association, the Condominium or any other property of the Owners Association.
- (14) To hire attorneys or other professionals for the purpose of bringing legal action or enforcing rights in the name of and on behalf of the members of the Owners Association where such actions or rights are common to all members, or a substantial number of the members; and to bring such action in the name of and on behalf of the members.
- (C) All funds and the title of all properties acquired by the Owners Association and their proceeds shall be held in trust for the members in accordance with the provisions of the declaration of condominium of the Condominium and by the By-Laws of the Owners Association.

## ARTICLE IV

## MEMBERS.

(A) The members of the Owners Association shall consist of all of the record owners of units in the Condominium and after termination of the Condominium, shall consist of those who are members at the time of such termination and their successors and assigns.

- (W) A change of membership in the Owners Association shall be established by recording in the public records of Walton County, Florida, a dead or other instrument establishing a record title to a unit in the Condominium and the delivery to the Owners Association of a certified copy of such instrument. The owner designated by such instrument thus becomes a member of the Owners Association and the membership of the prior owner is terminated.
- (C) The share of a member in the funds or assets of the Owners Association cannot be assigned, hypothecated or transferred in any manner except as an appurtunance to his unit.
- (D) The owner of each unit the Condominium shall be entitled to at least one (1) vote as a member of the Owners Association. The exact number of votes to be cast and the manner of exercising voting rights shall be determined by the By-Laws of the Owners Association.

# ARTICLE V

# DIRECTORS.

- (A) The affairs of the Owners Association will be managed by a Board consisting of not less than three (3) nor more than seven (7) directors who shall be designated or elected as hereinafter set Forth. Directors need not be members of the Owners Association.
- (B) The names and addresses of the members of the first Board of Directors who have been designated as such by the Developer and who shall hold office until their successors are designated or elected as herein provided and have qualified or until removed as herein provided are as follows:

Until unit owners other than the Developer are entitled to elect members of the Board of Directors, the members of the Board of Directors shall be designated by the Developer and may be changed from time to time as the Developer, in its sole discretion, may determine.

- (C) Until unit owners other than the Developer are antitled to elect at least a majority of the Board of Directors, the Board of Directors shall consist of three (3) members. The first election of Directors shall not be hald until required by the Condominium Act, including Section 710.301(1)(a)-(a) thereof, or until the Developer elects to terminate its control of the Owners Association. The provisions of Section 710.301(1)(a)-(e) are set forth in Article (D) below.
- (D) Section 710.301(1)(a-e) of the Condominium Act provides as follows:
  - \*718.301 Transfer of association control.-
  - (1) When unit owners other than the developer own 15 percent or more of the units in a condominium that will be operated ultimately by an association, the unit owners other than the developer shall be entitled to elect no less than one-third of the members of the board of administration of the association. Unit owners other than the developer are entitled to elect not less than a majority of the members of the board of administration of an association:
    - (a) Three years after 50 percent of the units that will be operated ultimately by the association have been conveyed to purchasers;
    - (b) Three months after 90 percent of the units that will be operated ultimately by the association have been conveyed to purchasers;
    - (c) When all the units that will be operated ultimately by the association have been completed, some of them have been conveyed to purchasers, and none of the others are being offered for sale by the developer in the ordinary course of business;
    - (d) When some of the units have been conveyed to purchasers and none of the others are being constructed or offered for sale by the developer in the ordinary course of business; or

- (w) Beven years after recordation of the declaration of condominium; or, in the unse of an annociation which may ultimately operate more than one condominium. 7 years after recordation of the declaration for the first condominium it operates, or, in the cane of an association operating a phase condominium orwated pursuant to \$718.403, 7 years after recordation of the declaration creating the initial phase, whichever occurs first. The developer is entitled to elact at least one member of the board of administration of an annociation as long as the developer holds for sale in the ordinary course of business at least 5 percent, in condominiums with fewer than 500 units, and 2 percent, in condominium with more than 500 units, of the units in a condominium operated by the association. Following the time the developer relinquishes control of the association, the developer may exercise the right to vote any developer-owned units in the same manner as any other unit owner except for purposes of recognizing control of the association or salecting the majority members of the board of administration.
- (E) Beginning with the election at which unit owners other than the Developer are entitled to elect at least a majority of the Board of Directors, the affairs of the Owners Association will be managed by a Board consisting of seven (7) directors. After unit owners other than the Developer are entitled to elect a majority of the members of the Board of Directors, directors of the Owners Association shall be elected at the annual meeting of the members in the manner determined by the By-Laws. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided by the By-Laws.

#### ARTICLE VI

OFFICERS. The affairs of the Owners Association shall be administered by the officers designated in the By-Laws. The officers shall be elected by the Board of Directors at its first meeting following the annual meeting of the members of the Owners Association and shall serve at the pleasure of the Board of Directors The names and addresses of the officers who shall until serve their successors are designated by the Board of Directors are as follows:

#### ARTICLE\_VII

Every director and every officer of the INDEMNIFICATION. Owners Association shall be indemnified by the Owners Association against all expenses and liabilities, including attorney's foos, remember indurred by or imposed upon him in donnaction with any proceeding or any nottlement of any proceeding to which he may be a party or in which he may become involved by reason of his being or having been a director or officer of the Owners Association, whether or not he is a director or officer at the time such expenses are incurred, except when the director or officer is adjudged guilty of willful misfeasance in the performance of his duties. The foregoing right of indemnification shall be in addition to and not exclusive of all of the rights to which such director or officer may be entitled. The directors shall be authorized to purchase directors and officers liability insurance providing coverage to the officers and directors of the Owners Association at the expense of the Owners Association.

# ARTICLE VIII

BY-LAWS. The first By-Laws of the Owners Association shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the By-Laws.

#### ARTICLE IX

AMENDMENTS. Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

(A) Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.

- amendment may be propound either by the Board of Directors or by the members of the Owners Association. Directors and members not present in person or by proxy at the mostling considering the amendment may express their approval in writing provided such approval is delivered to the secretary or assistant secondary at or prior to the menting. Except as classical provided, such approvals must be by not less than two-thirds (2/3) of the vote of the entire membership of the Owners Association:
- (c) Provided, however, that no amendment shall make any changes in the qualifications for membership nor the voting rights of members without approval in writing by all members and the joinder of all record owners of mortgages upon the Condominium.
- (D) Provided, further, that no amendment shall abridge, limit or alter the rights reserved by or granted to the Developer, its successors or assigns, or any successor developer, by these Articles or By-Laws without the prior written consent of the Developer, its successors or assigns, or a successor developer.
- (B) A copy of each amendment shall be certified by the Secretary of State and recorded in the public records of Walton County, Florida.

#### ARTICLE\_X

TERM. The term of the Owners Association shall be perpetual.
