ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation.

ARTICLE I - Name

The name of this Corporation shall be: THE TRUE HOLINESS CHURCH OF LOVE, INC..

ARTICLE II - Principal Office

The principal place of business and mailing address of this Corporation shall be: 6504 N. Meridian Road, Tallahassee, Florida 32312.

ARTICLE III - Purpose(s)

The purpose of this corporation shall be to establish and operate a Christian church as follows: (1) For the deepening of our spiritual life, so that all our members may attain and impress every Christian believer to seek the highest Christian experience possible in this life; (2) To ordain Elders, Pastors, Evangelists, Missionaries, Teachers, Divinely called and set apart according to their gifts and calling, who shall be required to teach and preach the doctrine set forth in the Basis of Union; (3) To enforce
